Circles of Support Volunteer Training

Prospective Volunteers will be provided with the following documents prior to training:

- 1. Program Description
- 2. Program Mission
- 3. Roles and Goals for Volunteers and Core Members
- 4. Right Relationship and Safety Guidelines for Volunteers and Core Members
- 5. Core Member Application
- 6. Volunteer Application

The expectation is that the documents will be read prior to training and that trainees will jot down any questions that their reading has provoked.

 - Weekly committeent for at least 6 months
 - Respect for the opinions of all Members every voice heard listening is key a Circle of equals
 - Volunteers do not provide material support but provide information to obtain resources a Volunteer's presence and friendship is the most valuable support
 - Respect for all faiths and beliefs
 - Volunteers challenge the Core Member to set realistic goals and hold him/her accountable to review progress
- Highlight a few of the expectations of Core Members
 - Commits to regular attendance at meetings and communicates in a timely way if a conflict arises ie: short notice court or probation sumnons or other personal needs
 - Respects all Circle Members

- Determines personal goals and agreeable to review and revise regularly
- Does not expect or ask for material support from Circle Members
- Expects confidentiality of shared information, but agrees to the sharing within the Circle or with others in the Circle of Support program

4. Right Relationships & Safety Guidelines for Volunteers and Core Members - Review document 4 (15 min)

- Hightlights from document
 - · Background checks of Volunteers
 - Training required
 - Confidentiality expected no information is to be shared outside of the Circle or the Circle of Support program
 - Measures to maintain emotional and physical safety
 - · Core Members to be at least 18 years of age
 - Any legally allowable information about a potential Core Member, will be shared with the Circle as a match is considered
 - If a Circle becomes aware of a Core Member violating probation, the Circle will encourage a self-report to the probation officer
 - In case of a life threatening emergency, Volunteers have a duty to warn and will call 911 and follow instructions
 - · Healthy boundaries to be respected and maintained
 - If a conflict of interest situation arises (ie: a relationship develops outside of the Circle between a Core Member and a Circle Volunteer or a Volunteer's family) it will be reviewed by the COS/Jail Ministry committee and next steps determined
 - No socialization is to occur outside of the Circle relationship
 - No exchange of material support
 - Meetings to be held in pre-arranged community locations where no alcohol is served and is agreeable to the Circle as a whole
 - If a Core Member shows up to a meeting inebriated, he/she will be advised that the Circle will not meet with him/her in that condition
 - There are to be no one on one meetings the Core Member with only one Circle Volunteer
